She has earned prize money, which she uses to care for and train her horses. She would like to compete at the NCAA level while in college. Also, Nash Hilmes is a Dirt Track Racing Driver. He wants to be a NASCAR driver. Nash just received a \$150,000 sponsorship. Mrs. Kristal LeRette thanked Mrs. Pat Corwin for her work with the after school program in Buda. Mrs. Kristie Cady introduced her track coaches, Maria Biagioni and Kristin Ledergerber. BVN IESA Track Qualifiers were introduced. Garrett Williams won a 6th place medal in the Shot Put. Mrs. Julie Decker-Platz introduced her track coaches, Pat Corwin and Jack Gustafson. BVS IESA Track Qualifiers were introduced. Medal winners included Ashley Nordstrom, 7th in Shot Put; Carter Salisbury, 7th in High Jump; and Jaden Michlig, 2nd in Discus and 3rd in Shot Put. Mr. Kevin Barnett, Transportation and Maintenance Director, spoke about the collaborative effort for the summer cleaning of our buildings. The staff will be moving from building to building as they clean one building at a time. Mrs. Vicki Litherland, Athletic Director, mentioned the success of the girls track team at the IHSA state track meet. Four boys qualified for the IHSA meet coming up this weekend. High School State Track qualifiers will be recognized at the June Board meeting. She also introduced Kristin Ledergerber, School Nurse, who spoke about the success of the Sports Physical Clinic. The issue was split into two components: \$2,530,000 of Taxable and \$9,470,000 of Tax Exempt. There is a 12 year payout period with a call feature after 5 years. It was moved by Wiggim and seconded by Johnson to approve Resolution providing for the issue of Taxable General Obligation School Building Bonds, Series 2018A, and General Obligation School Building Bonds, Series 2018B, of the District, for the purpose of building and equipping additions to and altering, repairing, equipping and improving the sites of District facilities, providing for the levy of a direct annual tax sufficient to pay the principal and interest on said bonds, and authorizing the sale of said bonds to the purchaser thereof.

Mr. Tyra also explained that they would be re-bidding the Earthwork and Concrete bids. These came in over budget. The plan is to break out some of the sanitation and sewer bids to attract some local contractors.

Mr. Tyra then spoke about the companies that submitted the lowest bids on the remaining projects. He is confident that the schedule will move along as planned.
